Ohio Medicaid Managed Care Members:

October 1 Launch of the Next Generation of Ohio Medicaid Program

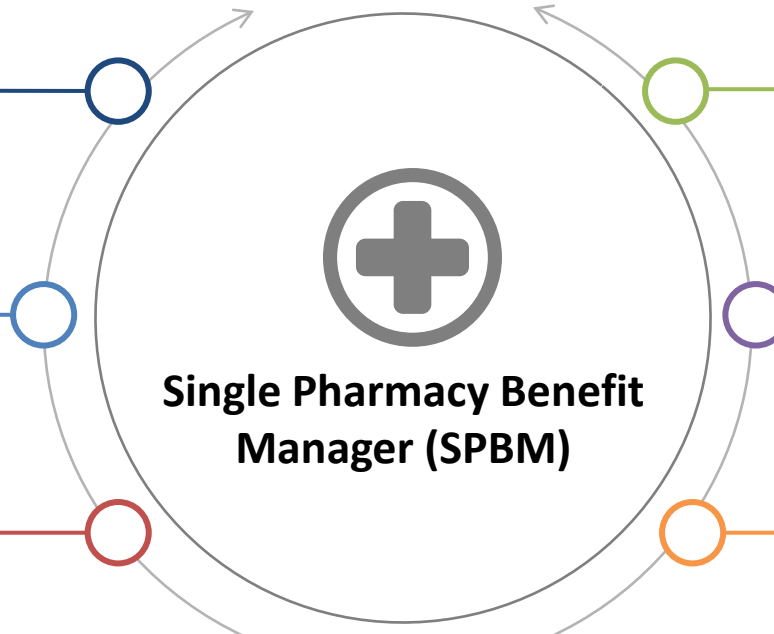
The Next Generation of Ohio Medicaid program is being implemented in stages to avoid unnecessary disruption and confusion for members and to reduce the burdens on our providers. The October 1 launch includes the implementation of Single Pharmacy Benefit Manager (SPBM). This does not apply to MyCare Ohio plans.

Key Changes as of October 1

All managed care members receive the same pharmacy benefits, regardless of which managed care plan they have.

Pharmacy benefits are covered through **Gainwell Technologies**.

New Next Generation managed care member ID card with pharmacy benefit information.



Key Benefits as of October 1

New managed care member ID cards allow Medicaid managed care and OhioRISE members to have **one ID card that includes all member information, including pharmacy benefit information**.

Receive the same pharmacy benefits in the Next Generation program, regardless of what managed care plan you have.

Better selection of pharmacies close to home and fewer out-of-network restrictions.

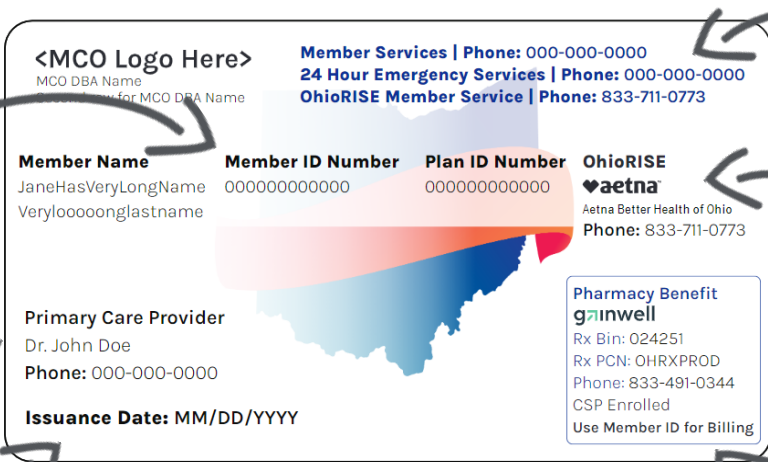
