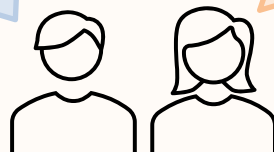
Impact Spotlight

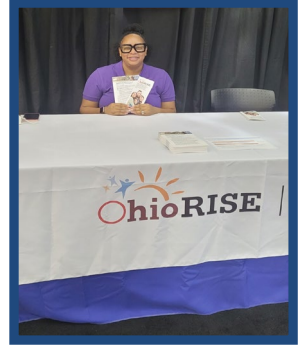
